Fees are set by Welsh Assembly Government and are detailed in the following schedule. You are advised that in a few circumstances fees may be exempt or reduced. Please take time to read this information to decide which is applicable to your application. The Local Planning Authority cannot determine your application until the correct fee has been submitted. Once an application has been registered fees are not refundable, irrespective of the eventual Council decision or if you withdraw your application.

The fee should be submitted with your application and cheque made payable to 'Wrexham County Borough Council', payments by Credit/Debit Cards is also accepted. These fees will apply from 6th April 2009.

## GENERAL NOTES

- Fees for the site area are based on the whole of the area to which the application relates, i.e. all the land being developed or changed by the proposal.
- Fees for floorspace are based on the gross floorspace of the building (all floors) and is measured to include the width of external walls.
- Applications to regularise unauthorised development are assessed on the same fee scale as new development.
- Where an application involves two or more different categories, then only the highest of the separate fees is payable. One exception, where fees are added, is if the proposal is for the erection of dwellings together with other non-residential buildings.
- Particular arrangements exist for applications where a development site crosses over to another Local Authority boundary. You are advised to check with the Planning Control Section for further details.

## EXEMPT FEES

### **No fee is payable for the following types of application:**

- Extension or alteration to a dwelling to improve the welfare of a person with disability or when works are to allow access by people with disabilities to a building to which the general public has access. Proof of registration should be provided.
- Where the proposed work would normally be classed as permitted development and permitted development rights have been removed.
- Where the proposed works would normally be classed as permitted development and an Article 4 Direction is in place.
- Re-submission of an application made within 12 months following refusal, or of the making of an earlier application if withdrawn, or within 12 months of expiry of the 8-week period where the applicant has appealed to the Secretary of State on the grounds of non-determination.
- Where the proposed use would have been a permitted change within the 'use class' but for the imposition of a restrictive condition on an earlier planning permission.

## REDUCED FEES

### **The following types of applications are eligible for a reduced fee:**

- When the application is made by, or on behalf of, a Community or Town Council, the fee is reduced by 50%.
- For alternative applications submitted at the same time for one site, the full fee for the highest value application and 50% of the fees for the remaining application(s) is payable.
