



**NOTICE OF CONFIRMATION & COMING INTO OPERATION**  
**OF PUBLIC PATH DIVERSION ORDER**  
**HIGHWAYS ACT 1980 SECTION 119**

THE COUNTY BOROUGH OF WREXHAM (PUBLIC FOOTPATH NO. 80 IN THE COMMUNITY OF BRYMBO) PUBLIC PATH DIVERSION ORDER 2010.

On 28 day of September 2011 the Wrexham County Borough Council confirmed and certified the above named Order made under section 119 of the Highways Act 1980.

The effect of the Order as confirmed and certified is to divert the public footpath described in Part 1 of the Schedule to this Notice to a line described in Part 2 of the Schedule to this Notice.

A copy of the Order as confirmed and certified and the Order plan have been placed and may be seen free of charge at the Guildhall, Wrexham and at the Post Office, Kirkham House, High Street, Brymbo from 9am until 4.30pm Mondays to Fridays. Copies of the Order and plan may be obtained free of charge from the Guildhall.

The Order will come into operation on 26 October 2011, but if any person aggrieved by the Order wants to question its validity or that of any provision contained in the Order, on the ground that it is not within the powers of the Highways Act 1980, as amended, or on the ground that any requirement of the Act, as amended, or of any regulation made under the Act has not been complied with in relation to the Order, pursuant to paragraph 2 of Schedule 2 to the Act as applied by paragraph 5 of Schedule 6 to the Act, he or she may make application to the High Court within six weeks from 6 October 2011.

**SCHEDULE**

**Part 1**

**Description of Site of Existing Path of Way**

That part of public footpath 80 in the Community of Brymbo shown by a bold continuous line commencing from point A (SJ 2591 5334) on the Order plan and continuing generally south east for approximately 74 metres to point B (SJ 2595 5328) on the Plan attached to this Notice.

**Part 2**  
**Description of Site of new Path or Way**

A footpath shown by a bold continuous line with short bars at intervals commencing from point A (SJ 2591 5334) on the Order plan and continuing generally south west then south for approximately 23 metres to a kissing gate at point C (SJ 2591 5332) on the Plan attached to this Notice and then south east for approximately 57 metres to point B (SJ 2595 5328) on the Plan attached to this Notice.

Width:           2.5 metres between SJ 2591 5334 (point A on the Plan attached to this Notice) and SJ 2595 5328 (point B on the Plan attached to this Notice).
