



NOTICE OF MAKING DEFINITIVE MAP MODIFICATION ORDER

THE WILDLIFE AND COUNTRYSIDE ACT 1981 SECTION 53

DEFINITIVE MAP AND STATEMENT OF PUBLIC RIGHTS

WREXHAM COUNTY BOROUGH COUNCIL (LLANGOLLEN RURAL 73, 115 AND
CHIRK 49) DEFINITIVE MAP MODIFICATION ORDER 2011

The above Order, made on 7 day of December 2011, if confirmed as made, will modify the Definitive Map and Statement for the area by deleting from them the byway open to all traffic 73 from grid reference SJ 2637 4034 on Order Plan 1 in a south, south-west direction to meet the county road and adding to them the footpath, the public right of way from the mentioned grid reference in a generally south east direction to meet the county road and downgrading to a footpath, part of Llangollen Rural byway 73, the public right of way from the junction with the county road at the properties known as Glas-fryn and Ty Newydd in a generally south west direction through Pen-y-graig quarry to the junction with Llangollen Rural Footpath 77 and then generally south-west across fields to grid reference SJ 2637 4034 on Order Plan 1 as described in the schedule below.

A copy of the Order and the Order map have been placed and may be seen free of charge at the office of Wrexham County Borough Council, Guildhall, Wrexham and the Post Office, Holyhead Road, Froncysyllte, Llangollen and the Post Office 2 Colliery Road, Chirk, from 9.00 am to 4.30 pm Mondays to Fridays. Copies of the Order and map may be obtained free of charge from the Guildhall, Wrexham.

Any representations or objections relating to the order must be sent in writing to Head of Corporate and Customer Services, Wrexham County Borough Council, Guildhall, Wrexham, LL11 1AY to be received not later than 27 January 2012 and applicants must include particulars of the grounds on which it is made.

If no representations or objections are duly made to the Order, or if any so made are withdrawn, the Wrexham County Borough Council, instead of submitting the Order to the National Assembly for Wales, may itself confirm the order. If the Order is submitted to the National Assembly for Wales, any representations or objections which have been duly made and not withdrawn will be sent with it.

SCHEDULE

Part I Modification of Definitive Map

DESCRIPTION OF PATH TO BE DELETED

The full width of that part of Llangollen Rural Byway Open to All Traffic 73 commencing from point D (SJ 2637 4034) on Order Plan 1 and continuing generally south south-west for approximately 60 metres to meet the county road at point G (SJ 2635 4028) on Order Plan 1 as attached to this Notice.

DESCRIPTION OF PATH TO BE ADDED

A footpath commencing from point D (SJ 2637 4034) on Order Plan 1 and continuing generally south east along a track for approximately 65 metres (crossing the community boundary at point E) to meet the county road at point F (SJ 2641 4029) on Order Plan 1 as attached to this Notice.

Width: 2 metres between point D and point F on Order Plan 1 as attached to this Notice.

Limitations: None

DESCRIPTION OF PATH TO BE DOWNGRADED

The full width of that part of Llangollen Rural Byway Open to All Traffic 73 to be downgraded to footpath commencing from the junction with the county road at the properties known as Glas-fryn and Ty Newydd at point A (SJ 2679 4088) on Order Plan 1 as attached to this Notice and continuing between the properties and generally south west along a well defined track for approximately 120 metres to point B (SJ 2670 4082) on Order Plan 1 as attached to this Notice then continuing generally south west for approximately 220 metres through Pen-y-graig quarry to the junction with Llangollen Rural footpath 77 at point C (SJ 2653 4068) on Order Plan 1 as attached to this Notice and then generally south south-west across fields for approximately 390 metres to point D (SJ 2637 4034) on Order Plan 1 as attached to this Notice.

Width: Varying between 2.7 metres and 7.5 metres as shown shaded grey between point A and point B on Order Plan 2 as attached to this Notice.

2 metres between point B and point D on Order Plan 1 as attached to this Notice.

Limitations: None
