



**NOTICE OF CONFIRMATION AND COMING INTO OPERATION  
OF PUBLIC PATH DIVERSION ORDER**

**HIGHWAYS ACT 1980 - SECTION 119**

**THE COUNTY BOROUGH OF WREXHAM (PUBLIC FOOTPATH NO.7 IN THE  
COMMUNITY OF LLAY) PUBLIC PATH DIVERSION ORDER 2010**

On 15 day of December 2010, the Wrexham County Borough Council confirmed the above named Order made under Section 119 of the Highways Act 1980.

The effect of the Order as confirmed is to divert the public footpath described in Part 1 of the Schedule to the route described in Part 2 of the Schedule as shown on the Order plan.

A copy of the Order as confirmed and the Order plan have been placed and may be seen free of charge at the office of Wrexham County Borough Council, Guildhall, Wrexham, LL11 1AY and Llay Sub-Post Office, Market Square, Llay, LL12 0BA from 9.00am to 4.30pm Mondays to Fridays. Copies of the Order and plan may be obtained free of charge at the Guildhall, Wrexham.

The Order comes into force on 29 December 2010, but if a person aggrieved by the Order wants to question its validity or that of any provision contained in it, on the ground that it is not within the powers of the Highways Act 1980, as amended, or on the ground that any requirement of the Act, as amended, or of any regulation made under the Act has not been complied with in relation to the Order, he or she may, under paragraph 2 of Schedule 2 to the Act as applied by paragraph 5 of Schedule 6 to the Act, within 6 weeks from 17 December 2010, make an application to the High Court.

**SCHEDULE**

**PART 1  
DESCRIPTION OF SITE OF EXISTING PATH OR WAY**

Public footpath 7 in the Community of Llay shown by a bold continuous line commencing from Llay public footpath 6 at point A (SJ 3349 5588) on the Order Plan and continuing generally north north-east through Oakfield Park Home Estate for approximately 290 metres, to meet Gresford Road at point B (SJ 3356 5615) on the Order Plan.

**PART 2**  
**DESCRIPTION OF SITE OF NEW PATH OR WAY**

A footpath shown by a bold continuous line with short bars at intervals commencing from Llay footpath 6 to the rear of numbers 68 and 70 Fifth Avenue at point C (SJ 3347 5589) on the Order Plan and continuing generally north and north-west along a tarmac path for approximately 80 metres to meet the service road for Oakfield Park Home Estate at point D (SJ 3346 5596) on the Order Plan then continuing generally north-west then north-east following the service road to a gap alongside a gate (the gap being to the western side of the gate) at point E (SJ 3345 5604) and passing through the gap and continuing north-east to meet Gresford Road at point F (SJ 3355 5615) on the Order Plan

Width: 2.0 metres between SJ 3347 5589 (point C on the Order Plan) and SJ 3355 5615 (point F on the order Plan) with an exception at SJ 3345 5604 (point E on the Order Plan) where the path narrows to 1.65 metres where the route goes through a gap next to a gate, the gap being to the western side of the gate.
