



NOTICE OF CONFIRMATION OF AN ORDER

HIGHWAYS ACT 1980

The County Borough of Wrexham (Public Footpath No 29 in the Community of Rossett (Formerly Allington) Public Path Diversion Order 2006

On 30 August 2006, Wrexham County Borough Council confirmed the above Order made under Section 119 of the Highways Act 1980.

The effect of the Order as confirmed is to divert the Public Footpath described in Part 1 of the Schedule to this Notice to a line described in Part 2 of the Schedule to this Notice.

A copy of the Order as confirmed and the Order map have been placed and may be seen free of charge at the Guildhall, Wrexham and the Post Office, Station Road, Rossett, LL12 0HE during normal office/opening hours. Copies of the Order and map may be obtained free of charge from the Guildhall, Wrexham.

The Order comes into force on 31 August 2006, but if a person aggrieved by the Order wants to question its validity, or that of any provision contained in it, on the ground that it is not within the powers of the Highways Act 1980, as amended, or on the ground that any requirement of the Act, as amended, or of any regulation made under the Act has not been complied with in relation to the Order, he or she may, under paragraph 2 of Schedule 2 to the Act as applied by paragraph 5 of Schedule 6 to the Act, within 6 weeks from 31 August 2006 make an application to the High Court.

SCHEDULE

Part 1

Description of site of existing path or way

That part of public footpath number 29 in the Community of Rossett (formerly Allington) in the County Borough of Wrexham from the driveway to Hem House Farm at grid reference 33869 35567 in a generally east-northeasterly direction for a distance of approximately 169 metres along the driveway and through the yard to a point at grid reference 33886 35571, then in a generally northerly direction for a distance of approximately 201 metres to the gate at grid reference 33887 35591, a total length of 370 metres of undetermined width as shown by a bold black line between points A-B-D on the map attached to this Notice.

Part 2

Description of site of new path or way

A public footpath, that is the path on which the public has a right of way on foot only, 1.8 metres in width, from on the driveway to Hem House Farm at grid reference 33869 35567 in a generally northeasterly direction for a distance of approximately 147 metres to a stile at grid reference 33878 35579, then in a generally northeasterly direction of approximately 151 metres to the gate at grid reference 33887 35591, a total length of 298 metres, as shown by a bold black broken line between points A-E-D on the map attached to this Notice.
