



HIGHWAYS ACT 1980

The County Borough of Wrexham (Public Footpath No. 9 in the Community of Coedpoeth (formerly Bersham)) Public Path Diversion Order 2003

On 14th July 2004, Wrexham County Borough Council confirmed the above Order made under Section 119 of the Highways Act 1980.

The effect of the Order as confirmed is to divert the Public Footpath described in Part 1 of the Schedule to this Notice to a line described in Part 2 of the Schedule to this Notice.

A copy of the Order as confirmed and the Order map have been placed and may be seen free of charge at the Guildhall, Wrexham and the Post Office, 7 High Street, Coedpoeth, Wrexham, LL11 3RY during normal office/opening hours. Copies of the Order and map may be obtained free of charge from the Guildhall, Wrexham.

The Order comes into force on 15th July 2004, but if a person aggrieved by the Order wants to question its validity, or that of any provision contained in it, on the ground that it is not within the powers of the Highways Act 1980, as amended, or on the ground that any requirement of the Act, as amended, or of any regulation made under the Act has not been complied with in relation to the Order, he or she may, under paragraph 2 of Schedule 2 to the Act as applied by paragraph 5 of Schedule 6 to the Act, within 6 weeks from 15th July 2004 make an application to the High Court.

SCHEDULE

Part 1

Description of site of existing path or way

That part of Public Footpath No. 9 in the Coedpoeth (formerly Bersham) in the County Borough of Wrexham from a point at grid reference 32928 35055 in a generally north-northwesterly direction for a distance of approximately 13 metres to the field boundary at grid reference 32927 35056 then in a generally westerly direction for a distance of approximately 29 metres to the turnstile at grid reference 32924 35057 of undetermined width, a total distance of approximately 42 metres as shown by a bold black continuous line between points A-B-C on the map attached to this Notice.

Part 2

Description of site of new path or way

A public footpath that is path over which the public has a right on foot only 1.8 metres in width from Public Footpath No. 9 in the Community of Coedpoeth (formerly Bersham) in the County Borough of Wrexham at grid reference 32928 35055 in a generally westerly direction for a distance of approximately 40 metres to a point at grid reference 32924 35056 then in a generally north-northeasterly direction parallel to the boundary fence for a distance of approximately 11 metres to the turnstile at grid reference 32924 35057 a total distance of approximately 51 metres as shown by a broken black line between A-D-C on the map attached to this Notice.
